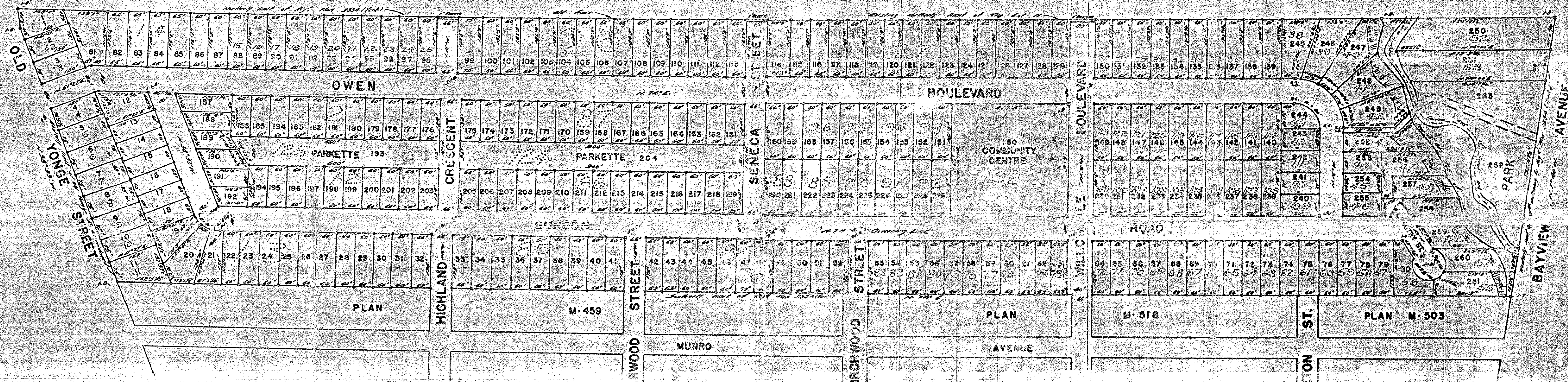


**PLAN
